
Dear Nelson:



Dear Colleagues:

As a neurosurgeon with a long standing interest in both acute and chronic pain, one of the major problems which I confront is to determine when a patient has a probably valid complaint of pain and when they may be exaggerating complaints for a variety of other reasons. Having validated testing to help make that differentiation has been a goal of the Johns Hopkins Pain Treatment Center since it was founded. I, with a number of other members of the Department of Neurosurgery and Pain Treatment Center participated in research to establish a valid measure for estimating low back pain and treatment effects upon it, these included the Hendler Back Pain Test, which subsequently became the Mensana Clinic Back Pain Test and a questionnaire utilized to predict organic pathology in chronic back and neck pain. One of the most important of these tools predicts the likelihood of a physical cause being found for complaints of chronic back, neck and radicular pain. These have culminated in a Pain Validity Test, which is now available over the internet in both English and Spanish. It is a self-administered form, which can be completed by a patient in about five minutes. The test predicts with statistically valid accuracy which patients are likely to have at least one objective medical test, which validates the origins of the pain. I append relevant references. Further information is available through one of the physicians who was responsible for much of this research. Dr. Nelson Hendler, M.D., M.S., is available at DocNelse@aol.com. I personally find these tests clinically useful and employ them regularly in my practice. I have no financial interests in any of them. Dear Nelson,

I am a Registered Nurse who works with the elderly in Long Term Care. My current practice keeps me interested in evidenced based pain assessment so this online test intrigued me. 
I am writing this letter in reference to Dr. Hendler's Pain Validity Test in a legal setting.







I have known you and your service TASA, since I became a lawyer almost 18 years ago. I have used your service time and again when my firm was literally stumped, and could not find any expert in a particular field or professional specialty.

The defense agreed that their experts had not done the battery of tests which Dr. Hendler had performed and their experts did not explain as effectively as Dr. Hendler the very real and painful condition that my client was suffering: RSDS. To make a very long case (four years) shorter, the defense ultimately settled for almost \$500,000.00 at the point when not only had we began the damages trial, but when it became obvious that Dr. Hendler would appear at the trial to testify in person.
